"contribute to the global battle against climate change by serving as an interim platform for the Partners to scale up REDD+ actions and finance, and to that end to take immediate action, including improving the effectiveness, efficiency, transparency and coordination of REDD+ initiatives and financial instruments, to facilitate among other things knowledge transfer, capacity enhancement, mitigation actions and technology development and transfer."

- Launch of the REDD+ Partnership website for enhanced information sharing, transparency and communication
- Commissioned study on the identification and analysis of financing gaps and overlaps

- Work program 2011-2012:
